Accountability...

You may have noticed in our financial report that we took more money in this month than we spent. It is rare that this happens. Usually, we report all the expenditures and show how we received the income to cover those exact expenditures. The Durango congregation's contribution each month is the difference between the expenditures and the income. Therefore, this month, the congregation did not contribute to the program because there were more than enough funds. The extra funds go into the general account, out of which we draw the Durango contribution each month.

Next month, I will be added to the list of expenditures since I will begin receiving support from the Intern Program. As we add interns, they also will be a part of the expenditures. At the moment, we have only one intern, so our expenditures will be lower than when we have three men on the payroll.

Notice the number of people from Durango in the financial report who give above their regular Sunday contribution to help this effort every month. This not only shows you the commitment we have here among the folks who actually see this work and the results it brings, but also it reveals the kind of heart these people have in their relationship with God. We've come a long way in the last 25 years in which we've worked together, and with God's help, we hope to continue moving forward.
